Sub: Reduction of percentile in NEET-UG score by 5% towards admission in ASU&H UG courses for the A.Y 2021-22

I am directed to refer the subject cited above and to say that considering the recommendation of both commissions (NCISM & NCH), the Ministry has decided to reduce the minimum percentile criteria of NEET-UG, 2021 score by 5 % across all categories towards admission in ASU&H UG (BAMS/BUMS/BSMS/BHMS) courses for the A. Y. 2021-22.




