Terms & Conditions and Instructions:

- a) The candidate must be a citizen of India.
- b) The candidates should have passed Matriculation with Punjabi or its equivalent examination of Matriculation Standard. However, the candidates (Group-A) who have not passed Punjabi as on the date of advertisement, he/she will have to pass Punjabi within three years from the date of joining.
- c) Any candidate who has been debarred by Guru Ravidas Ayurved University Punjab, Hoshiarpur or by any other University/State Government/Institution from any assignment shall not be eligible for the post.
- d) Age Limit:
 - 1. Upto 45 years for Ayurvedic Consultant/Assistant Professor/Resident Medical Officer.
 - 2. Upto 37 years for Physiotherapist and Upvaid (Pharmacist).
- e) Candidates who are not registered in the State of Punjab shall have to get themselves registered with the Board of Ayurvedic and Unani Systems of Medicine, Punjab within one month from the date of appointment.
- f) Candidates shall have to produce all original documents along with one set of self-attested photocopies, two recent passport-size photographs and Aadhar Card at the time of interview. No candidate shall be allowed to appear in the interview without original documents.
- g) The University reserves the right to increase or decrease the number of vacancies, withdraw any or all posts, not to fill the advertised posts, or postpone/cancel the advertisement/interview without assigning any reason.
- h) The selected candidate(s) may be transferred, at the discretion of the competent authority of the University, to any Institute under Guru Ravidas Ayurved University Punjab, Hoshiarpur within the State of Punjab in future.
- j) The selected candidate(s) shall initially be appointed on contract basis for a period of six months, which may be extended further depending upon performance and requirement of the University.
